






#### **Mid-Year Appeal**

With Summer comes high temperatures. We can not emphasize enough the steps that you need to take in order to keep your pet(s) safe in hot weather. Please take a look at the chart above for safety tips and the chart below to learn how to recognize heat stroke. I continue to see people walking their dog(s) in the middle of the afternoon when the temperature is well above 90 degrees. Imaging walking with a fur coat and bare feet on those hot sidewalks. Why would you subject your dog to such dangerous conditions? Consider purchasing a cooling vest and rubber soled booties.

People leaving their dog(s) unattended in their cars is not only against the law in California (see below for details) but also gives anyone the right to break your window in order to save pet's life. Leaving the windows cracked open does next to nothing to lower the fast rising temperature inside the car and it only takes minutes not hours for the pet to suffer adverse effects of extreme heat. Please do not let your dog become another statistic.

"Under California Penal Code 597.7 PC, it is illegal to leave an animal in an unattended motor vehicle under conditions that would endanger the health or well-being of the animal. A violation of the law can lead to misdemeanor charges and jail time."

This California statute provides that no person shall leave or confine an animal in any unattended motor vehicle under conditions that endanger the health or well-being of an animal due to heat, cold, lack of adequate ventilation, or lack of food or water, or other circumstances that could reasonably be expected to cause suffering, disability, or death to the animal. In 2016, rescue provisions were added that allows a person to remove an animal in danger from a vehicle provided he or she meets several criteria listed in the law. A first conviction for violation of this section is punishable by a fine not exceeding \$100 per animal. If the animal suffers great bodily injury, a violation of this section is punishable by a fine not exceeding \$500, imprisonment in a county jail not exceeding six months, or by both a fine and imprisonment. Penalty enhancements are provided for subsequent convictions.

of our dedicated veterinary providers with a special gift.



- Towels
- Small flashlight
- Alcohol wipes
- Styptic powder
- Saline eye solution
- Artificial tear gel
